## **PURPOSE**

The purpose of this bulletin is to notify all Workforce Development System (WDS) contractors that the Economic and Workforce Development Department (EWDD) has released the Request for Proposals for YouthSource Center (YSC) Operators for the South San Fernando Valley and South Los Angeles/Watts YSCs.

## **NOTICE**

The City of Los Angeles Economic and Workforce Development Department (EWDD) released the YSC Operator RFP for South San Fernando Valley and South Los Angeles/Watts on Monday, October 17, 2022. This RFP seeks to solicit proposals from organizations or individuals interested in managing a YSC serving youth ages 16 - 24 in the specified City Planning Areas with a focus on engaging disconnected youth with school or work, improving student retention, and bolstering academic proficiency. The YSC will be expected to provide support and career and workforce development services to youth in the City of Los Angeles. Successful respondents will be responsible for leading local partners to increase resources and outcomes for disconnected youth.

Community-based organizations, non-profit organizations, private organizations, educational institutions, and public agencies may submit proposals to this RFP. Specific eligibility and other requirements are set out in the RFP, which is posted at the Regional Alliance Marketplace for Procurement website ([www.RAMPLA.org](http://www.RAMPLA.org)). Please note that a virtual proposers' conference is scheduled for October 27, 2022. **The proposal submission deadline is on Friday, December 9, 2022 at 5:00pm.**
